Bids should be submitted in sealed envelopes, delivered at the **O/o Director (C&P), TDP, Tarbela** on or before **1100 hours** on **10.04.2023** and must be accompanied by a Bid Security of **Rs. 40,000/-** for Sr. No.1 bid in the form of unconditional Bank Guarantee (on prescribed form of Bid Security in the bidding document) or in the form of **CDR in favour of GM & PD, TDP**.

Bids will be opened on the same day at 1130 hours for Sr. No. (1) in the presence of the bidders or their authorized representatives who choose to attend at the **O/o Director (C&P), Tarbela Dam Project**.

This procurement will be carried out as per PPRA rules, 2004 (single stage –one envelope) as amended time to time.

The employer reserves the rights to accept or reject any or all bids or proposals at any time prior to acceptance of a bid or proposal.

Note: The Bidder must meet with the following Qualification Criteria:-

- Specific Experience = One or more similar nature assignment, substantially completed with contract price up to Rs. one Million or more during last 4 years. Also provide completion/substantial completion certificate from concerned employer / client.
